

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(ENROLLMENT - MARCH)

RES. NO. 23-82

1 WHEREAS, the Papago Council has reviewed the recommendations of the Papago

3 of the Papago Enrollment Ordinance, Ordinance No. 05-81, and has

1 NOW, THEREFORE, BE IT RESOLVED that it is hereby determined that the above
2 named applicants are eligible for enrollment as members of the
3 Papago Tribe under Section 1 (a) or (b) of Article II of the
4 Papago Constitution and By-laws, as amended, and their applications
5 are approved, as herein above indicated.


6 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of
7 the Papago Tribe reduce this final determination in writing
8 regarding each of the foregoing applications for enrollment in
9 accordance with Section 1 (C) of Article VIII of the Papago
10 Enrollment Ordinance; give notice of this Council's determination
11 in accordance with Section 2 (a) and (b) of Article VIII of the
12 Papago Enrollment Ordinance; and place the names of each applicant
13 upon the Tribal Membership Roll in accordance with Article IX of
14 the Papago Enrollment Ordinance.

15 The foregoing Resolution was duly enacted by the Papago Council on the 10th
16 day of March, 1982, at a meeting at which a quorum was present with a vote of
17 1048.0 for; 0 against; 100.0 not voting; and 0 absent,
18 pursuant to the authority vested in the Papago Council by Article II and
19 Article V, Section 2 (f) of the Constitution and By-laws of the Papago Tribe
20 of Arizona as amended, ratified by the Papago Tribe on December 12, 1936,
and approved by the Secretary of the Interior on January 6, 1937, pursuant
to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution
is not subject to review by the Secretary of the Interior and is effective
as of the date of its enactment by the Papago Council.
