

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

(Approving Amendment of Hickiwan)  
(District FY 1982 Budget )

RES. NO. 24-82

1 WHEREAS, the Papago Council did approve the FY 1982 budget for the Hickiwan  
2 District; and

3 WHEREAS, such budget did not include funds available to, and unused by the  
4 District in its FY 1981 budget totaling \$6,445.35; and

5 WHEREAS, the Hickiwan District Council did on February 6, 1982, by Resolution  
6 No. 02-82 approve the carryover of the sum of \$6,445.35 from the  
7 FY 1981 budget to the FY 1982 budget, and did on March 6, 1982,  
8 adopt a FY 1982 budget amendment totalling \$20,970.00 which includes  
9 the \$6,445.35 carryover from FY 1981; and

10 WHEREAS, the Papago Council has reviewed the budget and budget justifications  
11 for the amended Hickiwan District FY 1982 budget and approves of  
12 same.

13 NOW, THEREFORE, BE IT RESOLVED that amendment of the FY 1982 District Budget  
14 of the Hickiwan District is hereby approved and the District is  
15 hereby authorized to expend funds in the District IIM Account in  
16 accordance with the attached FY 1982 Budget Amendment totalling  
17 \$20,970.00.

18 The foregoing Resolution was duly enacted by the Papago Council on the 10th  
19 day of March, 1982, at a meeting at which a quorum was present with a vote of  
20 1064.0 for; 0 against; 84.0 not voting; and 1 absent,  
21 pursuant to the authority vested in the Papago Council by Section 3 (a) of  
22 Article V of the Constitution and By-laws of the Papago Tribe of Arizona as  
23 amended, ratified by the Papago Tribe on December 12, 1936, and approved by  
24 the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of  
25 the Act of June 18, 1934 (48 Stat. 984). Said Resolution is effective as of  
26 the date of its approval by the Superintendent of the Papago Agency and is  
27 subject to review by the Secretary of the Interior.
