

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL  
(Setting Date for Revenue Sharing Public Hearing)

RES. NO. 27-82

1 WHEREAS, it is necessary to have a public hearing for proposed uses of  
2 federal Revenue Sharing funds.


3 NOW, THEREFORE, BE IT RESOLVED that the public hearing for proposed uses  
4 of federal Revenue Sharing funds shall be held in Sells on  
5 April 16, 1982, and that notice of such hearing shall be given  
6 as required by law.

7 The foregoing Resolution was duly enacted by the Papago Council on the 10th  
8 day of March, 1982, at a meeting at which a quorum was present with a vote of  
9 592.0 for; 565.0 against; 0 not voting; and 2 absent,  
10 pursuant to the authority vested in the Papago Council by Section 2 (f) of  
11 Article V of the Constitution and By-laws of the Papago Tribe of Arizona as  
12 amended, ratified by the Papago Tribe on December 12, 1936, and approved by  
13 the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of  
14 the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to  
15 review by the Secretary of the Interior and is effective as of the date of  
16 its enactment by the Papago Council.
