

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL  
(Prohibiting Holding of International Treaty)  
(Council Conference in Chukut Kuk District )

RES. NO. 29-82

1 WHEREAS, the International Treaty Council has announced that it would hold  
2 its 8th Annual Conference in the Chukut Kuk District; and

3 WHEREAS, the Chukut Kuk District Council did on January 9, 1982, hear and  
4 refuse the request by the International Treaty Council to hold  
5 the Conference in its District; and

6 WHEREAS, Ordinance No. 04-82, requires that organizations which are not  
7 organized under the authority and control of either the Papago  
8 Council or of a District Council intending to conduct a meeting  
9 or event that will attract non-members of the Papago Tribe to the  
10 Papago Reservation shall first obtain the permission and permit  
11 of the District Council in which such meeting or event is proposed  
12 to occur; and

13 WHEREAS, the International Treaty Council would violate the provisions of  
14 Ordinance No. 04-82 if it conducted the 8th Annual Conference in  
15 the Chukut Kuk District without the District Council's permission  
16 and permit.

17 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it prohibits the  
18 proposed meeting of the 8th Annual Conference of the International  
19 Treaty Council in the Chukut Kuk District without the specific  
20 permission and permit of the District Council.

21 BE IT FURTHER RESOLVED that officers, agents and employees of the Papago  
22 Tribe and of Federal Agencies having jurisdiction within the Papago  
23 Reservation, including but not limited to the Bureau of Indian  
24 Affairs and the United States Immigration and Custom Services, are  
25 hereby directed or requested to aid in the prevention of any  
26 violation of law by officers, members or invitees of the International  
27 Treaty Council, including but not limited to violations of Ordinance  
28 No. 04-82.

29 The foregoing Resolution was duly enacted by the Papago Council on the 6th  
30 day of April, 1982, at a meeting at which a quorum was present with a vote of  
31 762.0 for; 83.0 against; 303.0 not voting; and 0 absent,  
32 pursuant to the authority vested in the Papago Council by Section 2 (a) and  
(h) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona  
as amended, ratified by the Papago Tribe on December 12, 1936, and approved by  
the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the  
Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review  
by the Secretary of the Interior and is effective as of the date of its  
enactment by the Papago Council.
