

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Approving Application for Preliminary)
(Loan for Low Income Public Housing)

RES. NO. 32-82

1 WHEREAS, it is the policy of this locality to eliminate substandard and other
2 inadequate housing, to prevent the spread of slums and blight, and
3 to realize as soon as feasible the goal of a decent home in a suitable
4 living environment for all of its citizens; and

5 WHEREAS, under the provisions of the United States Housing Act of 1937, as
6 amended, the United States of America, acting through the Secretary
7 of Housing and Urban Development (herein called the "Government"),
8 is authorized for undertaking and carrying out preliminary planning
9 of low income housing projects that will assist in meeting this
10 goal; and

11 WHEREAS, the Act provides that there shall be local determination of need for
12 low income housing to meet needs not being adequately met by private
13 enterprise and that the Government shall not make any contract with
14 a public housing agency for preliminary loans for surveys and
15 planning in respect to any low-income housing project unless the
16 governing body of the locality involved has by resolution approved
17 the application of the public housing agency for such preliminary
18 loan; and

19 WHEREAS, Section 213 of the Housing and Community Development Act of 1974
20 provides that the local unit of government be given the opportunity
21 to comment on and/or object to the approval of an application on
22 grounds of inconsistency with local housing assistance planning; and

23 WHEREAS, the Papago Indian Housing Authority (herein called "Local Authority"),
24 is a public housing agency and is applying to the Government for a
25 preliminary loan to cover the costs of surveys and planning in
26 connection with development of low-income housing.

27 NOW, THEREFORE, BE IT RESOLVED by the Governing Council of the Papago Tribe
28 as follows;

- 29 1. That there exists within the jurisdiction of this Governing
30 Council a need for such low-income housing which is not
31 being met by private enterprise;
32 2. That the application of the Local Authority of the Govern-
ment for a preliminary loan in an amount not to exceed 3%

of the Total Development Cost which can be supported by the amount of the ACC for surveys and planning in connection with low income housing projects of not to approximately 50 dwelling units is hereby approved.

- 3. That there is no objection to the Local Authority's application to HUD for additional housing (a) due to any inconsistency localities under consideration; or (b) since a definite need for the housing exists even though a Housing Assistance Plan may not be in effect; and (c) since public facilities and services are or will be available and adequate to serve the proposed housing the areas mentioned.

The foregoing Resolution was duly enacted by the Papago Council on the 6th day of April, 1982, at a meeting at which a quorum was present with a vote of 1094.0 for; 27.0 against; 27.0 not voting; and 2 absent, pursuant to the authority vested in the Papago Council by Section 2 (a) and (h) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
