

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(ENROLLMENT - APRIL)

RES. NO. 33-82

1 WHEREAS, the Papago Council has reviewed the recommendations of the Papago
2 Enrollment Committee in accordance with Section 1 of Article VIII
3 of the Papago Enrollment Ordinance, Ordinance No. 05-81, and has
4 made a final determination that the applications of the following

24 named applicants are eligible for enrollment as members of the
25 Papago Tribe under Section 1 (a) or (b) of Article II of the
26 Papago Constitution and By-laws, as amended, and their
27 applications are approved, as herein above indicated.

28 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers
29 of the Papago Tribe reduce this final determination in writing
30 regarding each of the foregoing applications for enrollment in
31 accordance with Section 1 (c) of Article VIII of the Papago
32 Enrollment Ordinance; give notice of this Council's determination


1 in accordance with Section 2 (a) and (b) of Article VIII of the
2 Papago Enrollment Ordinance; and place the names of each applicant
3 upon the Tribal Membership Roll in accordance with Article IX of
4 the Papago Enrollment Ordinance.

5 The foregoing Resolution was duly enacted by the Papago Council on the 7th
6 day of April, 1982, at a meeting at which a quorum was present with a vote of
7 1148.0 for; 0 against; 0 not voting; and 1 absent,
8 pursuant to the authority vested in the Papago Council by Article II and
9 Article V, Section 2 (f) of the Constitution and By-laws of the Papago Tribe
10 of Arizona as amended, ratified by the Papago Tribe on December 12, 1936,
11 and approved by the Secretary of the Interior on January 6, 1937, pursuant
12 to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution
13 is not subject to review by the Secretary of the Interior and is effective
14 as of the date of its enactment by the Papago Council.
