

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Grievance Hearing)

RES. NO. 34-82

1 WHEREAS, the Papago Council was requested by Judge Hilda Manuel to hear
2 an employment grievance and has heard testimony concerning the
3 grievance and the administrative supervision and operation of
4 the Papago Tribal Courts.

5 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that the Chairman
6 and the Law and Order Committee review the rules and procedures
7 of the Papago Tribal Courts dealing with leave, disciplinary
8 actions, grievances and other administrative court matters
9 with the judges of the courts in order to assure a uniform
10 and fair application thereof.

11 BE IT FURTHER RESOLVED by the Papago Council that any disciplinary
12 actions or sanctions presently pending or previously taken or
13 imposed against Judge Hilda Manuel are hereby vacated and set
14 aside and that she shall forthwith be paid any compensation
15 withheld pursuant to such actions or sanctions.

16 The foregoing Resolution was duly enacted by the Papago Council on the 7th
17 day of April, 1982, at a meeting at which a quorum was present with a vote of
18 826.0 for; 185.5 against; 136.5 not voting; and 3 absent,
19 pursuant to the authority vested in the Papago Council by Section 2 (e) and (f)
20 of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as
21 amended, ratified by the Papago Tribe on December 12, 1936, and approved by
22 the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of
23 the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to
24 review by the Secretary of the Interior and is effective as of the date of
25 its enactment by the Papago Council.
