
1 WHEREAS, the Papago Council feels there is a lack of communication between  
2 the Executive Health Staff of the Papago Tribe and the Office of  
3 Research and Development of the Indian Health Service; and

4 WHEREAS, the Papago Council believes that it would be fruitful to have  
5 a meeting with all parties present in order to resolve  
6 outstanding problems.


7 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that officials of  
8 the Office of Research and Development of the Indian Health  
9 Service and the Executive Health Staff be invited to attend  
10 the Council meeting in order to review and resolve problems  
11 concerning the Papago Tribe's health programs.

12 The foregoing Resolution was duly enacted by the Papago Council on the 7th  
13 day of May, 1982, at a meeting at which a quorum was present with a vote of  
14 1080.0 for; 84.0 against; 84.0 not voting; and 4 absent,  
15 pursuant to the authority vested in the Papago Council by Section 2 (e) of  
16 Article V of the Constitution and By-laws of the Papago Tribe of Arizona as  
17 amended, ratified by the Papago Tribe on December 12, 1936, and approved by  
18 the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of  
19 the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to  
20 review by the Secretary of the Interior and is effective as of the date of  
21 its enactment by the Papago Council.
