

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Concerns of Elderly Program)

RES. NO. 43-82

1 WHEREAS, members of the staff of the Elderly Program have submitted testimony
2 concerning the operation of the Program and certain personnel
3 problems involving the Program; and

4 WHEREAS, the Papago Council finds such personnel matters are not properly
5 before this Council but should be processed in accordance with the
6 provisions of the Personnel Policies and Procedures Manual of the
7 Papago Tribe.

8 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that the personnel
9 matters brought before this Council be processed pursuant to the
10 Personnel Policies and Procedures Manual.


11 BE IT FURTHER RESOLVED that the oral testimony submitted before this Council
12 be resubmitted in the form of a written report to the Council.

13 The foregoing Resolution was duly enacted by the Papago Council on the 7th
14 day of May, 1982, at a meeting at which a quorum was present with a vote of
15 788.0 for; 0 against; 360.0 not voting; and 2 absent,
16 pursuant to the authority vested in the Papago Council by Section 2 (e) and
17 (f) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona
18 as amended, ratified by the Papago Tribe on December 12, 1936, and approved by
19 the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of
20 the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to
21 review by the Secretary of the Interior and is effective as of the date of
22 its enactment by the Papago Council.
