

RESOLUTION OF THE PAPAGO COUNCIL  
(Addition of 9th grade to Santa)  
(Rosa Boarding and Day School)

RES. NO. 44-82

1 WHEREAS, both the staff and Board of the Santa Rosa Boarding and Day  
2 School have recommended the addition of a 9th grade so as  
3 to establish an Elementary School, consisting of grades kindergarten  
4 through 6th grade and a Junior High School consisting of grades  
5 7 through 9, at the Santa Rosa Boarding and Day School which  
6 added grade would serve an additional 80 to 100 Papago students;  
7 and

8 WHEREAS, the addition of a 9th grade is consistent with the longterm  
9 objective of the Papago Tribe of establishing a kindergarten  
10 through 12th grade facility at the Santa Rosa Boarding and Day  
11 School, and is consistent with the proposed phase out of off-  
12 reservation schools by the Bureau of Indian Affairs.


13 NOW, THEREFORE BE IT RESOLVED by the Papago Council that it does hereby  
14 fully support and endorse the recommendation of the Board of  
15 the Santa Rosa Boarding and Day School that a 9th grade be added  
16 starting in fall of 1982, and that a High School, consisting  
17 of grades 10 through 12, be added as soon thereafter as possible.

18 The foregoing resolution was duly enacted by the Papago Council on the 7th  
19 day of May, 1982, at a meeting at which a quorum was present with a vote of  
20 1148 for; 0 against; 0 not voting; and 2 absent,  
21 pursuant to the authority vested in the Council by Section 2 (d) and (k) of  
22 Article V of the Constitution and By-Laws of the Papago Tribe as amended,  
23 ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary  
24 of the Interior on January 6, 1937, pursuant to Section 16 of the Act of  
25 June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by  
26 the Secretary of Interior and is effective as of the date of its enactment by  
27 the Papago Council.
