

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL  
(Papago Skill Center/HIP Housing)

RES. NO. 45-82

1 WHEREAS, the Papago Tribal Government established the O'Odham Construction  
2 by Resolution No. 58-80 and the Papago Skill Center by Resolution  
3 No. 04-79, both are 100% tribally owned and operated; and  
4 WHEREAS, the Papago Tribe established the Papago Skill Center in its official  
5 name; and  
6 WHEREAS, the Papago Skill Center has trained 60 Papagos in construction  
7 trades since the Center opened in August and proposes to place its  
8 construction trades graduates with the O'Odham Construction; and  
9 WHEREAS, the Papago Skill Center has constructed four model homes with the  
10 floor plans and construction techniques that are acceptable to the  
11 Union and the Bureau of Indian Affairs.  
12 NOW, THEREFORE, BE IT RESOLVED that the Papago Tribe hereby authorizes the  
13 O'Odham Construction to enter into a Construction Contract pursuant  
14 to CFR 261.3 with the Bureau of Indian Affairs for the HIP Housing  
15 Program to build ten (10) homes.  
16 BE IT FURTHER RESOLVED that the authorized contract should not exceed \$307,000.  
17 which is presently available at the Papago Agency for the benefit  
18 of the Papago Indians.  
19 The foregoing Resolution was duly enacted by the Papago Council on the 7th  
20 day of May, 1982, at a meeting at which a quorum was present with a vote of  
21 1107.0 for; 0 against; 41.0 not voting; and 2 absent,  
22 pursuant to the authority vested in the Papago Council by Section 2 (e) and  
23 (f) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona  
as amended, ratified by the Papago Tribe on December 12, 1936, and approved by  
the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the  
Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review  
by the Secretary of the Interior and is effective as of the date of its  
enactment by the Papago Council.
