Designating Judge Hilda Manuel Chief
Judge of the Papago Tribal Court


1 WHEREAS, Henry F. Manuel, Chief Judge of the Papago Tribal Court, has
2 rendered his resignation; and

3 WHEREAS, Judge Hilda Manuel has indicated an interest to assume the
4 position of Chief Judge for the unexpired term of Judge Henry
5 F. Manuel, i.e. until October 1982, provided she receive a
6 salary of \$22,700. per year.


7 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that Judge Hilda
8 Manuel is hereby designated Acting Chief Judge of the Papago
9 Tribal Court for the unexpired term of Judge Henry F. Manuel.
10 at an annual salary of \$22,700.

11 The foregoing Resolution was duly enacted by the Papago Council on the 13th
12 day of May, 1982, at a meeting at which a quorum was present with a vote of
13 335.0 for; 375.5 against; 393.5 not voting; and 3 absent,
14 pursuant to the authority vested in the Papago Council by Section 2 (e) and
15 (f) of Article V of the Constitution and By-laws of the Papago Tribe of
16 Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and
17 approved by the Secretary of the Interior on January 6, 1937, pursuant to
18 Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is
19 not subject to review by the Secretary of the Interior and is effective as
20 of the date of its enactment by the Papago Council.
