

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL  
San Xavier District/Mountain Bell - Easement

RES. NO. 55-82


1 WHEREAS, residents of Twin Buttes Road by Black Mountain in the San Xavier  
2 District on both Tribal and allotted land (#101, #152, #160, #194,  
3 #196 and #210) are desirous of getting telephones installed in  
4 their homes; and  
5 WHEREAS, the Mountain Bell Company has existing telephone lines right-of-way  
6 across a portion of said District and is interested in extending  
7 its service to serve residents of the Village on condition that it  
8 can obtain necessary easements for periods of fifty (50) years  
9 with waivers of compensation and the rights to construct, operate,  
10 repair and remove improvements placed thereon, and to transfer its  
11 interest in the easement by assignment, grant or otherwise; and  
12 WHEREAS, the San Xavier District Council did pass a Resolution, 2-82-4, on  
13 February 16, 1982, approving the grant of a right-of-way easement  
14 to Mountain Bell; since the benefit of the telephone service will  
15 more than off-set any monetary consideration; and  
16 WHEREAS, the required signatures have been secured for the allotments  
17 involved (#101, #152, #160, #194, #196 and #210).  
18 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby  
19 consent to grants of easement to Mountain Bell, its successors  
20 and assigns, for rights-of-way for the installation, repair,  
21 maintenance, replacement and removal of telephone cables and  
22 improvements on, over, across in and upon the Tribal lands of  
23 San Xavier District for service to, and requested by residents  
24 of the District.  
25 BE IT FURTHER RESOLVED that such easements be for periods of fifty (50)  
26 years; that compensation for grants thereof be waived; and that  
27 such easements, and any interest therein, be subject to transfer  
28 by assignment, grant or otherwise.  
29 BE IT FURTHER RESOLVED that the foregoing consent to grants of easement to  
30 service residents of San Xavier District shall be a continuing  
31 one and shall be in full force and effect until revoked by the  
32 Papago Council.

1 The foregoing Resolution was duly enacted by the Papago Council on the 17th  
2 day of May, 1982, at a meeting at which a quorum was present with a vote of  
3 1042.0 for; 0 against; 106.0 not voting; and 2 absent,  
4 pursuant to the authority vested in the Papago Council by Section 2 (a) and  
5 (c) of Article V of the Constitution and By-laws of the Papago Tribe of  
6 Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and  
7 approved by the Secretary of the Interior on January 6, 1937, pursuant to  
8 Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is  
9 not subject to review by the Secretary of the Interior and is effective as  
10 of the date of its enactment by the Papago Council.
