

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

Report on Revenue Sharing
Monies from Previous Years

RES. NO. 56-82

1 WHEREAS, the Papago Council did on April 14, 1982 and May 17, 1982, hold
2 Public Hearings to receive testimony concerning proposed uses
3 of the Papago Tribe's Revenue Sharing allocation for FY 1982;
4 and


5 WHEREAS, the Papago Council heard from the former Revenue Sharing
6 Coordinator of unexpended funds from monies left over in the
7 Revenue Sharing office budget, line item for Public Hearings,
8 and interest on investments in the years 1979, 1980 and 1981,
9 which may be used to fund the Public Hearings and the Revenue
10 Sharing office and allowing availability of additional funds
11 to the Papago people; and

12 WHEREAS, the Papago Council wishes to receive a report of such funds
13 at its next regularly scheduled Council meeting.


14 NOW, THEREFORE, BE IT RESOLVED that the Papago Council shall receive a
15 report concerning the Revenue Sharing funds from 1979, 1980
16 and 1981, at its next regularly scheduled Council meeting.

17 The foregoing Resolution was duly enacted by the Papago Council on the 17th
18 day of May, 1982, at a meeting at which a quorum was present with a vote of
19 1148.0 for; 0 against; 0 not voting; and 2 absent,
20 pursuant to the authority vested in the Papago Council by Section 2 (f) of
21 Article V of the Constitution and By-laws of the Papago Tribe of Arizona as
22 amended, ratified by the Papago Tribe on December 12, 1936, and approved by
23 the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of
24 the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to
25 review by the Secretary of the Interior and is effective as of the date of
26 its enactment by the Papago Council.
