

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Papago Skill Center/HIP Housing)

RES.NO. 57-82

1 WHEREAS, the Papago Tribal Government established the Papago Skill Center
2 by Resolution No. 04-79 and the O'Odham Construction by Resolution
3 No. 58-80, both are 100% tribally owned and operated; and

4 WHEREAS, the Papago Tribe established the Papago Skill Center in its
5 official name; and

6 WHEREAS, the Papago Skill Center has trained 60 Papagos in construction
7 trades since the Center opened in August, 1981, and proposes to
8 place its construction trades graduates with the O'Odham
9 Construction; and

10 WHEREAS, the Papago Skill Center has constructed four (4) model homes
11 with the floor plans and construction techniques that are
12 acceptable to the Union and the Bureau of Indian Affairs.


13 NOW, THEREFORE, BE IT RESOLVED that it does hereby authorize the Papago
14 Tribe Skill Center to enter into a Construction Contract with
15 the Bureau of Indian Affairs pursuant to CFR 261.3 in accordance
16 with the attached budget for a multi-year HIP Housing Program to
17 build ten (10) homes in 1982 and as many additional homes in 1983
18 as may be built. The proposed date for commencement of contract
19 is upon the signature of the Chairman of the Papago Tribe.

20 The foregoing Resolution was duly enacted by the Papago Council on the 9th
21 day of June, 1982, at a meeting at which a quorum was present with a vote of
22 1060.5 for; 87.5 against; 0 not voting; and 0 absent,
23 pursuant to the authority vested in the Papago Council by Section 2 (e) and
24 (f) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona
as amended, ratified by the Papago Tribe on December 12, 1936, and approved by
the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of
the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to
review by the Secretary of the Interior and is effective as of the date of its
enactment by the Papago Council.
