NO. 58-82 WHEREAS, the San Lucy District Council did by the attached resolution 1 2 approve their share of the Revenue Sharing allocation to be 3 disbursed as described therein; and 4 WHEREAS, the San Lucy District has proclaimed the construction of their 5 clinic to be the number one priority in their district; and 6 WHEREAS, the Papago Council has been unable to find funds to assist 7 in the construction of the clinic. 8 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby 9 direct the San Lucy District to allocate \$10,000.00 of their 10 Revenue Sharing funds to aid in the construction of the clinic. 11 The foregoing Resolution was duly enacted by the Papago Council on the 9th day of June, 1982, at a meeting at which a quorum was present with a vote of 583.5 for; 112.0 against; 425.5 not voting; and 0 absent, pursuant to the authority vested in the Papago Council by Section 2 (f) of 12 13 Article V of the Constitution and By-Laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the 14 Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
