

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
Authorizing Withdrawal of \$4,571.72 from
Hickiwan District IIM Account

RES. NO. 74-82

1 WHEREAS, the Papago Council did by Resolution No. 24-82, approve the Hickiwan
2 District budget which had appropriated \$4,571.72 to the South
3 Hickiwan Community Affairs Committee, to be expended in accordance
4 with its approved budget; and

5 WHEREAS, in order to facilitate the administration of the South Hickiwan
6 Community Affairs Committee's functions it is necessary for the
7 Committee to establish and expend the funds appropriated to the
8 Committee from a bank account in Ajo, Arizona.

9 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
10 authorize the withdrawal of \$4,571.72 from the Hickiwan District
11 IIM Account to the order of the South Hickiwan Community Affairs
12 Committee, to be deposited in a bank in Ajo, Arizona, and to be
13 expended by the Committee in accordance with the Committee's
14 budget, as approved by the Hickiwan District Council.

15 The foregoing Resolution was duly enacted by the Papago Council on the 18th
16 day of June, 1982, at a meeting at which a quorum was present with a vote of
17 1148.0 for; 0 against; 0 not voting; and 1 absent,
18 pursuant to the authority vested in the Papago Council by Section 3 (a) and (h)
19 of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as
20 amended, ratified by the Papago Tribe on December 12, 1936, and approved by the
21 Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act
22 of June 18, 1934 (48 Stat. 984). Said Resolution is effective as of the date
23 of its approval by the Superintendent of the Papago Agency and is subject to
24 review by the Secretary of the Interior.




