Papago Housing - Delinquencies



1 WHEREAS, the Papago Housing Authority has advised the Papago Council
2 that because of substantial existing delinquencies in rental
3 and purchase payments future HUD funding on the Papago
4 Reservation may be in jeopardy and that it is important to
5 increase collections, particularly from employees of the Papago
6 Tribe.


7 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
8 approve of the attached form letter to be sent to persons
9 delinquent in their payments to the Papago Housing Authority
10 and who are employees of the Papago Tribe and does hereby direct
11 the Chairman of the Papago Council to sign the letter for use
12 by the Authority.

13 The foregoing Resolution was duly enacted by the Papago Council on the 5th
14 day of August, 1982, at a meeting at which a quorum was present with a vote
15 of 1148.0 for; 0 against; 0 not voting; and 2 absent,
16 pursuant to the authority vested in the Papago Council by Section 2 (e) and
17 (f) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona
18 as amended, ratified by the Papago Tribe on December 12, 1936, and approved by
19 the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the
20 Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review
21 by the Secretary of the Interior and is effective as of the date of its
22 enactment by the Papago Council.
