

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL  
San Lucy District Budget Amendment FY 1982 - 1983

RES. NO. 02-84

1 WHEREAS, the San Lucy District Council did on October 11, 1982, by  
2 District Resolution, approve a budget for fiscal year 1983  
3 in the amount of \$47,682.57; and  
4 WHEREAS, the total expenditures incurred by the San Lucy District  
5 totaled \$52,728.76 during the fiscal year 1983; and  
6 WHEREAS, the expenditures benefitted the members of the San Lucy  
7 District; and  
8 WHEREAS, the San Lucy District Council is requesting a modification  
9 of its FY 1983 budget to reflect the actual expenditures; and  
10 WHEREAS, the Papago Council has reviewed the request for the budget  
11 modification and approves of the same.  
12 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby  
13 approve the modification of the FY 1983 budget of the San Lucy  
14 District and authorizes the addition of \$5,046.19 to the  
15 original amount of \$47,682.57.

16 The foregoing Resolution was duly enacted by the Papago Council on the 4th  
17 day of January, 1984, at a meeting at which a quorum was present with a vote  
18 of 928.5 for; 0 against; 511.5 not voting; and 0 absent,  
19 pursuant to the authority vested in the Papago Council by Section 3 (a) and  
20 (h) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona  
21 as amended, ratified by the Papago Tribe on December 12, 1936, and approved by  
22 the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of  
23 the Act of June 18, 1934 (48 Stat. 984). Said Resolution is effective as of  
24 the date of its approval by the Superintendent of the Papago Agency and is  
25 subject to review by the Secretary of the Interior.
