## RESOLUTION OF THE PAPAGO TRIBAL COUNCIL Authorizing Purchase of Land for San Lucy District

RES. NO. 03-84

WHEREAS, the Papago Council did by Resolution No. 63-83, authorize the appropriate officers, attorney and agents of the Papago Tribe to 2 negotiate with Mr. Ernie Jordan for the acquisition by the Tribe 3 of 234.4 acres of land adjoining the San Lucy District in order to meet the needs of the District for more land to provide its 4 members with homesites and business resources; and 5 WHEREAS, an appraisal by the B.I.A. of said acreage establishes a fair 6 market value of \$160,000.00 or \$684.00 per acre; and WHEREAS, Mr. Jordan continues to ask \$1,300.00 per acre, or a total purchase price of \$351,600.00, which is more than twice its 8 appraised value; and 9 WHEREAS, during negotiations with Mr. Jordan, the San Lucy District did receive an offer of sale from Eleanor A. Logan, a real estate 10 broker acting on behalf of an undisclosed principal, to sell 297 11 acres of land lying on both sides of Interstate 8, at the inter-12 section with First Guide Road, Gila Bend, Arizona, for \$507.00 per acre, or the sum of \$150,000.00, payable \$50,000.00 upon 13 closing, with the balance due in two equal annual installments 14 of \$50,000.00, respectively 12 and 24 months after closing, plus 15 interest at 10% per annum on the unpaid balance, after date of 16 closing; and WHEREAS, the San Lucy District Council has recommended the acquisition of 17 these 297 acres of land by the Tribe as part of the San Lucy District. 18 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby 19 authorize the appropriate officers, attorneys and agents of the Tribe to negotiate the acquisition of these 297 acres of land by 20 the Tribe as part of the San Lucy District, and does hereby 21 request the Bureau of Indian Affairs to provide the Tribe with 22 expert advice in these negotiations. The foregoing Resolution was duly enacted by the Papago Council on the 4th 23 day of January, 1984, at a meeting at which a quorum was present with a vote not voting; and 0 0 of 1440.0 for; against; 24 pursuant to the authority vested in the Papago Council by Section 2 (a) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1937, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to 26 review by the Secretary of the Interior and is effective as of the date of

its enactment by the Papago Council.
