

6 NOW, THEREFORE, BE IT RESOLVED that it is hereby determined that the above
7 named applicants are eligible for enrollment as members of the
8 Papago Tribe under Section 1 (a) or (b) of Article II of the
9 Papago Constitution and By-laws, as amended, and that their
10 applications are approved, as herein above indicated.

11 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers
12 of the Papago Tribe reduce this final determination in writing
13 regarding each of the foregoing applications for enrollment in
14 accordance with Section 3 (c) of Article III of the Papago
15 Tribal Enrollment Ordinance; give notice of this Council's
16 determination in accordance with Section 4 of Article III of
17 the Papago Tribal Enrollment Ordinance; and place the names of
18 each applicant upon the Tribal membership roll in accordance
19 with Article V of the Papago Tribal Enrollment Ordinance.


20 The foregoing Resolution was duly enacted by the Papago Council on the 5th
21 day of January, 1984, at a meeting at which a quorum was present with a vote
22 of 1325.5 for; 0 against; 114.5 not voting; and 0 absent,
23 pursuant to the authority vested in the Papago Council by Section 1 (a) of
24 Article II and Section 2 (f) of Article V of the Constitution and By-laws of
25 the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on
26 December 12, 1936, and approved by the Secretary of the Interior on January 6,
27 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said
28 Resolution is not subject to review by the Secretary of the Interior and is
29 effective as of the date of its enactment by the Papago Council.
