(Processing Adoption Applications of Deceased Applicants)


1 WHEREAS, the Enrollment Committee has received applications for adoption
2 into membership in the Papago Tribe pursuant to Section 2 of Article
3 II of the Constitution of the Papago Tribe from applicants who died
4 before the Committee could process their applications; and

5 WHEREAS, the Enrollment Committee has requested advice from the Papago Council
6 concerning the disposition of such applications.


7 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that the Enrollment
8 Committee is directed to process adoption applications of deceased
9 applicants in accordance with its customary procedures with notices
10 to be given to the deceased's spouse and/or heirs.

11 The foregoing Resolution was duly enacted by the Papago Council on the 31st
12 day of May, 1984, at a meeting at which a quorum was present with a vote of
13 368.5 for; 608.0 against; 463.5 not voting; and 2 absent, pursuant
14 to the authority vested in the Papago Council by Section 2 (f) of Article V
15 of the Constitution and By-laws of the Papago Tribe of Arizona as amended,
16 ratified by the Papago Tribe on December 12, 1936, and approved by the
17 Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act
18 of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review
19 by the Secretary of the Interior and is effective as of the date of its
20 enactment by the Papago Council.
