WHEREAS, the Papago Council has reviewed the form and content of the attached Notice.

NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby approve the attached Notice and authorizes the Enrollment Committee to use for the purposes therein set forth.

The foregoing Resolution was duly enacted by the Papago Council on the 31st day of May, 1984, at a meeting at which a quorum was present with a vote of 1200.5 for; 239.5 against; -0- not voting; and 3 absent, pursuant to the authority vested in the Papago Council by Section 2 (e), (f) and (h) of Article V and Article II of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
