

WHEREAS, The Papago Council has reviewed the proposed provision concerning the loss of membership if a person is convicted of a major felonious crime and finds the same to be appropriate;

NOW, THEREFORE, BE IT RESOLVED by the Paapgo Council that it does hereby accept and approve of the inclusion of the proposed provision requiring the loss of membership and all rights deriving from membership if an individual has been convicted of the major crimes of murder or voluntary manslaughter.

The foregoing Resolution was duly enacted by the Papago Council on the 5th day of June, 19 84, at a meeting at which a quorum was present with a vote of 740.0 for; 535.0 against; 165.0 not voting; and -0- absent, pursuant to the authority vested in the Papago Council by Section 2 (f) of Article V and Article IX of the Constitution and by-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
