8	approve the proposed budget for Community Services Block grant funds
9	and authorizes the expenditure of such funds for those identified areas.

11	day of July, 1984, at a meeting at which a quorum was present with a vote of
	1440.0 for; -O- against; -O- not voting; and -1- absent, pursuant to the authority vested in the Papago Council by Section 2 (a) and (d) of Article
12	V of the Constitution and by-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary
13	of the Interior on January 6, 1937, pursuant to Seciton 16 of the Act of June
14	18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by
15	the Papago Council.
