


RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

Santa Cruz Farms



1 WHEREAS, The Santa Cruz Farms is a project established by the Pisinemo
2 District and is managed by the Pisinemo Development Authority, a
3 non-profit association chartered by the Papago Council; and
4 WHEREAS, The Santa Cruz Farms has established its primary goal entrepreneurial
5 farming with the objective of becoming a self-sufficient entity; and
6 WHEREAS, the shortage of water has resulted in less acreage being cultivated
7 which in turn has limited the farm products planted and harvested
8 offered to for marketing purposes; and
9 WHEREAS, It would be to the benefit of the Pisinemo District and potential
10 consumers of Santa Cruz Farms products to increase the farm
11 production; and
12 WHEREAS, Additional funds are required to accomplish any additional cultiva-
13 tion; and
14 WHEREAS, The Pisinemo Development Authority is desirous of seeking any jobs
15 bill funds which have not been expended by Tribes nationally; and
16 WHEREAS, It is the intent of the Papago Tribe to Contract for any residual
17 Jobs Bill funds to operate the Santa Cruz Farm project;
18 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
19 request and authorize the Bureau of Indian Affairs to identify any
20 unobligated or residual Jobs Bill funds in any Area Office through-
21 out the United States, and to enter into a Contract pursuant to the
22 regulations and procedures of P.L. 93-638 to operate the Santa Cruz
23 Farm project in accordance with the scope of work; and
24 BE IT FURTHER RESOLVED by the Papago Council that Josiah Moore, Chairman,
25 Francisco Jose Jr., Vice-Chairman or Rosita Ruiz, Treasurer, are
26 hereby authorized and directed to apply for, negotiate and execute
27 any and all contracts, amendments and other documents for implementa-
28 tion of this Contract upon notification by the Bureau of Indian Affairs
29 that funds have been found and reprogrammed for use at Santa Cruz Farms.
30 The foregoing Resolution was duly enacted by the Papago Council on the 11th
31 day of July, 1984, at a meeting at which a quorum was present with a vote of
32 1387.5 for; -0- against; 52.5 not voting; and -0- absent, pursuant to
the authority vested in the Papago Council by Section 2 (a) and (h) of Article
V of the Constitution and by-laws of the Papago Tribe of Arizona as amended,
ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary
of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June
18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the
Secretary of the Interior and is effective as of the date of its enactment by
the Papago Council.
