	and qualifying applicants; and
9	WHEREAS, The Headstart program has prepared a proposal for FY 85 program
10	operations to be submitted to the Department of Health & Human
11	Services; NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it hereby approves
12	the proposal for continued funding of the Headstart program and
13	directs the Chairman, Josiah Moore, or Francisco Jose, Vice-Chairman
	or Rosita Ruiz, Treasurer to apply for, and execute any and all
14	contracts, amendments and other documents which may be necessary to
15	implement the funding for the headstart program;
16	BE IT FURTHER RESOLVED that the duration of this Contract will be from
17	November 01, 1984 through October 31, 1985 unless extended by mutual
18	agreement of both contracting parties;
19	BE IT FURTHER RESOLVED that in the event this Contract is not in effect on November 01, 1984 the existing FY 84 contract will be continued until
	such time as the FY 85 Contract is in effect; and
20	BE IT FURTHER RESOLVED by the Papago Council that the Papago Tribe will not
21	fund or operate the program in the interim while negotiations are
22	still being conducted and no executed Contract has been awarded by
23	the Department of Health & Human Services.
24	The foregoing Resolution was duly enacted by the Papago Council on the <u>11th</u> day of July, 1984, at a meeting at which a quorum was present with a vote of
25	1440.0 for; -0- against; -0- not voting; and -0- absent, pursuant to the authority vested in the Papago Council by Section 2 (a) and (h) of Article
	V of the Constitution and by-laws of the Papago Tribe of Arizona as amended,
26	ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June
27	18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by
28	the Papago Council.
