

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

Early Childhood Head Start
Papago Human Service Grant

Res. No. 143-84

1 WHEREAS, The Papago Tribe has recognized the importance of early childhood
2 education and stimulation; and
3 WHEREAS, The Papago Tribe has operated a Headstart program to provide and
4 serve educational and pre-school learning experiences for children
5 between the ages of 3-5 years; and
6 WHEREAS, The Department of Health & Human Services, Administration for Children
7 Youth & Families, has provided funding for the operation of the
8 Headstart program; and
9 WHEREAS, The administration for Children, Youth & Families will provide funds
10 for the continued operation of the Headstart program to eligible
11 and qualifying applicants; and
12 WHEREAS, The Headstart program has prepared a proposal for FY 85 program
13 operations to be submitted to the Department of Health & Human
14 Services;

15 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it hereby approves
16 the proposal for continued funding of the Headstart program and
17 directs the Chairman, Josiah Moore, or Francisco Jose, Vice-Chairman
18 or Rosita Ruiz, Treasurer to apply for, and execute any and all
19 contracts, amendments and other documents which may be necessary to
20 implement the funding for the headstart program;


21 BE IT FURTHER RESOLVED that the duration of this Contract will be from
22 November 01, 1984 through October 31, 1985 unless extended by mutual
23 agreement of both contracting parties;

24 BE IT FURTHER RESOLVED that in the event this Contract is not in effect on
25 November 01, 1984 the existing FY 84 contract will be continued until
26 such time as the FY 85 Contract is in effect; and

27 BE IT FURTHER RESOLVED by the Papago Council that the Papago Tribe will not
28 fund or operate the program in the interim while negotiations are
29 still being conducted and no executed Contract has been awarded by
30 the Department of Health & Human Services.

31 The foregoing Resolution was duly enacted by the Papago Council on the 11th
32 day of July, 1984, at a meeting at which a quorum was present with a vote of
1440.0 for; -0- against; -0- not voting; and -0- absent, pursuant to
the authority vested in the Papago Council by Section 2 (a) and (h) of Article
V of the Constitution and by-laws of the Papago Tribe of Arizona as amended,
ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary
of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June
18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the
Secretary of the Interior and is effective as of the date of its enactment by
the Papago Council.
