


RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
Allocation of Revenue Sharing for Sells
District

Res. No. 144-84

1 WHEREAS, The Papago Council did by formal action, Resolution No. 122-83
2 allocate Revenue Sharing Entitlement funds to each of the eleven
3 districts of the Papago Reservation to be expended in accordance
4 with identified priorities and budgets; and
5 WHEREAS, The Sells District Council has reviewed District priorities and
6 needs and determined to distribute the allocation of \$15,063.81
7 equally among the four communities of Big Fields, Cowlic, North
8 Villages and Sells; and
9 WHEREAS, The equal distribution amounts to \$3,765.95 and will be expended
10 by the four communities in accordance with the attached budget;
11 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it has reviewed
12 the Sells District Council's proposed use for Revenue Sharing funds
13 and approves of the expenditures in accordance with the attached
14 budget;

15 The foregoing Resolution was duly enacted by the Papago Council on the 11th
16 day of July, 1984, at a meeting at which a quorum was present with a vote of
17 1440.0 for; -0- against; -0- not voting; and -0- absent, pursuant to
18 the authority vested in the Papago Council by Section 2 (a) and (h) of Article
19 V of the Constitution and by-laws of the Papago Tribe of Arizona as amended,
20 ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary
21 of the Interior on January 6, 1937, pursuant to Section 16 of the Act of
22 June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the
23 Secretary of the Interior and is effective as of the date of its enactment by
24 the Papago Council.
