

6 NOW, THEREFORE, BE IT RESOLVED that it is hereby determined that the above
7 named applicants are eligible for enrollment as members of the
8 Papago Tribe under Section 1 (a) or (b) of Article II of the
9 Papago Constitution and By-laws, as amended, and that their
10 applications are approved, as herein above indicated.

11 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of
12 the Papago Tribe reduce this final determination in writing regarding
13 each of the foregoing applications for enrollment in accordance with
14 Section 3 (c) of Article III of the Papago Tribal Enrollment
15 Ordinance; give notice of this Council's determination in accordance
16 with Section 4 of Article III of the Papago Tribal Enrollment
17 Ordinance; and place the names of each applicant upon the Tribal
18 membership roll in accordance with Article V of the Papago Tribal
19 Enrollment Ordinance.

20 The foregoing Resolution was duly enacted by the Papago Council on the 13th
21 day of July, 1984, at a meeting at which a quorum was present with a vote of
22 1386.5 for; -0- against; 53.5 not voting; and -2- absent, pursuant to
23 the authority vested in the Papago Council by Article II and Article V, Section
24 2 (f) of the Constitution and by-laws of the Papago Tribe of Arizona as amended,
25 ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary
26 of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June
27 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the
28 Secretary of the Interior and is effective as of the date of its enactment by
29 the Papago Council.
