20 NOW, THEREFORE, BE IT RESOLVED that it is hereby determined that the above
21 named applicants are eligible for enrollment as members of the Papago
22 Tribe under Section 2 of Article II of the Papago Constitution and
23 By-laws, as amended, and that their applications are approved, as
herein above indicated.


24 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of the
25 Papago Tribe reduce this final determination in writing regarding each
26 of the foregoing applications for enrollment in accordance with Sec-
27 tion 3 (c) of Article III of the Papago Tribal Enrollment Ordinance;
28 give notice of this Council's determination in accordance with Section
29 4 of Article III of the Papago Tribal Enrollment Ordinance; and place
30 the names of each applicant upon the Tribal membership roll in accord-
31 ance with Article V of the Papago Tribal Enrollment Ordinance.

1 The foregoing Resolution was duly enacted by the Papago Council on the 13th.
2 day of July, 1984, at a meeting at which a quorum was present with a vote of
3 1333.0 for; -0- against; 107.0 not voting; and 1 absent, pursuant
4 to the authority vested in the Papago Council by Article II and Article V,
5 Section 2 (f) of the Constitution and By-laws of the Papago Tribe of Arizona
6 as amended, ratified by the Papago Tribe on December 12, 1936, and approved
7 by the Secretary of the Interior on January 6, 1937, pursuant to Section 16
8 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject
9 to review by the Secretary of the Interior and is effective as of the date
10 of its enactment by the Papago Council.
