4	the proposed budget for FY-85 in the amount of \$181,679.60 said						
	budget period to begin on August 01. 1984 and end on July 31, 1985. WHEREAS, The Sif Oidak District maintains an account at the First Interstate						
5	Bank, Casa Grande and has authorized the following officers of the						
6	Council to have authority to sign checks on the Account, the Chairman,						
7	Vice-Chairman and Administrative Secretary.						
8	WHEREAS, The Sif Oidak District Council has sufficient funds in its IIM						
	Account to cover the proposed budget; and						
9	NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby						
10	approve the attached FY 84/85 budget of the Sif Oidak District						
11	and authorizes expenditures in accordance therewith;						
12	BE IT FURTHER RESOLVED by the Papago Council that it does hereby authorize						
	the Sif Oidak District Council to maintain a separate District						
13	Checking and/or Savings Accounts with the First Interstate Bank						
14	of Arizona, Casa Grande, Arizona, which shall provide that any of the following officers of the District Council, i.e., the						
15	Chairman, Vice-Chairman and the Administrative Secretary.						
16	BE IT FURTHER RESOLVED that the Papago Council does hereby give authority						
17	to the Sif Oidak District to transfer funds on deposit in the						
	District's IIM account into an account with the First Interstate						
18	Bank of Arizona in Casa Grande, an amount not to exceed one half						
19	of the total District budget, \$90,839.80 and remainder to be						
20	transferred when needed to meet the District's budgeted expenses.						
21	The foregoing Resolution was duly enacted by the Papago Council on the <u>13th</u> . day of July, 1984, at a meeting at which a quorum was present with a vote of						
22	1440.0 for; -O- against; -O- not voting; and -O- absent, pursuant to the authority vested in the Papago Council by Section 2 (a) and (d) of Article						
23	V of the Constitution and by-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the						
24	Secreatary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject						
25	to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
