## RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

Motion to accept the Resignation to extend Mr. George Esquivel for one year Res. No. 155-84

1 WHEREAS, The Papago Council has been advised of the retirement of George Esquivel from the Office of Environmental Health, Indian Health 2 Service; and 3 WHEREAS, The Papago Tribal Utility Authority (PTUA) has informed the Papago 4 Council of Mr. Esquivel's efforts and support in implementing a transfer of certain functions of his office to the Tribe, PTUA; and 5 WHEREAS, PTUA has requested support for the extension of Mr. Esquivel's employ-6 ment beyond his retirement date to facilitate an orderly and complete 7 transfer of those functions to be taken over by PTUA; NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it hereby supports 8 the request of Papago Tribal Utility Authority to extend the employment 9 term of Mr. George Esquivel upon Mr. Esquivel's approval, for one 10 year period; and

BE IT FURTHER RESOLVED by the Papago Council that it hereby requests approval from the Indian Health Service to utilize Mr. Esquivel's experience and knowledge to effect a transfer to PTUA those functions of the Sanitation Facilities Construction branch of the Office of Environmental Health for which PTUA is capable of performing.

The foregoing Resolution was duly enacted by the Papago Council on the 13th day of July, 1984, at a meeting at which a quorum was present with a vote of 961. for; 341. against; 138. not voting; and -0- absent, pursuant to the authority vested in the Papago Council by Section 2 (a), (d) and (f) of Article V of the Constitution and by-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
