

RESOLUTION OF THE PAPAGO COUNCIL
(Appealing Refusal by Area Director to)
(Approve Papago Council Resolution No. 121-84)

2 WHEREAS, the Papago Council did by Resolution No. 121-84 reject
3 the candidates certified by the Bureau of Indian Affairs
4 ("Bureau") as being qualified to serve in the position
5 of Superintendent of the Papago Agency; express
6 the Tribe's intention to enter into a contract with
7 the Bureau for the position of Superintendent, directed
8 the Chairman to appoint a committee to evaluate the
9 decision and prepare the necessary plans and time
10 frames to ensure an orderly and efficient transition;
11 and requested that the detail of Raymond Wolf as
12 Acting Superintendent of the Papago Agency be extended
13 until a contract has been implemented; and

14 WHEREAS, the Area Director did by memorandum dated June 15,
15 1984, direct the Acting Superintendent of the Papago
16 Agency to refuse to approve Resolution No. 121-84, and
17 the Superintendent did by letter delivered to Josiah
18 Moore, Chairman of the Papago Council, on June 13, 1984,
19 advise the Papago Council of his refusal to approve
20 Resolution No. 121-84; and


21 WHEREAS, the Papago Council has reviewed the memorandum of the
22 Area Director and the reasons given by him for directing
23 to the Acting Superintendent to refuse his approval
24 of Resolution No. 121-84, and finds that these reasons
25 are insufficient;

26 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that, for
27 the reasons stated in the attached Memorandum, it
28 does hereby appeal the action of the Area Director in
29 directing the Acting Superintendent to refuse his
30 approval of Resolution No. 121-84, and does hereby
31 direct the firm of Strickland & Altaffer, General
32 Counsel for the Papago Tribe, to process the appeal in


1 accordance with the provisions of 25 C.F.R. Part 2.

2 The foregoing Resolution was duly enacted by the Papago Council
3 on the 13th day of July, 1984, at a meeting at which
4 a quorum was present with a vote of 1319.5 for; 69
5 against; 51.5 not voting; and 1 absent, pursuant to the
6 authority vested in the Council by Section 2 (b) and (f) and
7 Section 6 of Article V of the Constitution and By-Laws of the
8 Papago Tribe as amended, ratified by the Papago Tribe on December
9 12, 1936, and approved by the Secretary of the Interior on
10 January 6, 1937, pursuant to Section 16 of the Act of June 18,
11 1934 (48 Stat. 984). Said Resolution is not subject to review
12 by the Secretary of Interior and is effective as of the date of
13 its enactment by the Papago Council.
