RESOLUTION OF THE PAPAGO TRIBAL COUNCIL Approval of Tribal Budgets for FY 1985

Res No 169-84

WHEREAS, The Papago Council is empowered to have control of all Tribal funds 1 and to appropriate such funds for the expenses of Tribal business 2 and government; and 3 WHEREAS, The Papago Council has delegated the Budget and Finance Committee to review and recommend tribal expenditure budgets; and 4 WHEREAS, The Papago Council has reviewed the recommendations of the Budget 5 and Finance Committee and approves the expenditure budgets for FY 6 85 in the amount of \$3,929,600.00 based on estimated Revenue of \$3,929,600.00; and 7 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby 8 approve and adopt the FY 85 Papago Tribal Budgets and does hereby 9 authorize the expenditure of Tribal funds in accordance therewith. The foregoing Resolution was duly enacted by the Papago Council on the 9th day 10of August, 1984 at a meeting at which a quorum was present with a vote of 1130.0 for; -O- against; -O- not voting; and 2 absent, pursuant to the 11 authority vested in the Papago Council by Section 3 (a) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified 12 by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 13 (48 Stat. 984).
