1	WHEREAS, The Papago Council has reviewed the FY 85 Tribal budgets and finds no						
2	increase in per diem rates for Council members; and						
3	WHEREAS, The Papago Council has not received an increase in per diem since 1980 with the exception of a one time bonus given in 1983; and						
4	WHEREAS, The Papago Council feels it is time for an increase in per diem rates						
	paid to Council representatives;						
5	NOW THEREFORE BE IT RESOLVED by the Papago Council that it does hereby approve						
6	and authorize a per diem rate increase for Papago Council representa-						
7	tives from \$103.50 to \$150.00; such increase to become effective upon						
8	commencement of the new fiscal year, 1985.						
	The foregoing Resolution was duly enacted by the Papago Council on the 9th day						
9	of August, 1984, at a meeting at which a quorum was present with a vote of 786.5 for; 222.5 against; 324 not voting; and 2 absent, pursuant to the						
10	authority vested in the Papago Council by Section 2 (f) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified						
11	by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18,						
12	11934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary						
13	of the Interior and is effective as of the date of its enactment by the Papago Council.
