


RESOLUTION OF THE PAPAGO TRIBAL COUNCIL  
Approval for Grant request - Venito Garcia Library

Res No 174-84


1 WHEREAS, The Education Department has provided reading and library services  
2 to interested persons, particularly to school aged children through  
3 its library department, the Venito Garcia Library; and  
4 WHEREAS, The funds appropriated for the expenses of the library are provided  
5 through the Education department's annual budget; and  
6 WHEREAS, The State of Arizona Department of Library, Archives and Public  
7 Records, provides funds for use in library operations and has  
8 tentatively approved a funding request from the Venito Garcia Library  
9 upon the execution of an Intergovernmental agreement; and  
10 WHEREAS, Receipt of these funds would enable the Venito Garcia Library to  
11 provide additional library services; and  
12 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby  
13 approve the proposal submitted to the Department of Library, Archives  
14 and Public Records for funding of the Venito Garcia Library and  
15 authorizes the Chairman, Josiah Moore, or Francisco Jose, Vice-  
16 Chairman or Rosita Ruiz, Treasurer to execute any and all documents  
17 required for receipt of the funds from the State of Arizona, Depart-  
18 ment of Library, Archives and Public Records.

19 The foregoing Resolution was duly enacted by the Papago Council on the 9th day  
20 of August, 1984, at a meeting at which a quorum was present with a vote of  
21 1333.0 for; -0- against; -0- not voting; and 2 absent, pursuant to the  
22 authority vested in the Papago Council by Section 2 (a) and (f) of Article V  
23 of the Constitution and By-laws of the Papago Tribe of Arizona as amended,  
24 ratified by the Papago Tribe on December 12, 1936, and approved by the  
25 Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the  
26 Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to re-  
27 view by the Secretary of the Interior and is effective as of the date of its  
28 enactment by the Papago Council.
