WHEREAS, The Hickiwan District Council has adopted and approved an amendment to its FY 84 Budget to reflect costs it will incur to complete the Pre-School/Multi Purpose building and to complete and operate the gas service project; and

WHEREAS, The FY 84 budget is \$150,793.00 and with the addition of \$77,975.00 it will total \$228,768.00; and

WHEREAS, The Hickiwan District has sufficient funds in its IIM Account to cover the addition of \$77,975.00; and

WHEREAS, The Hickiwan District maintains an account at the Valley National Bank in Ajo, Arizona, and has authorized the following officers of the District Council to have authority to sign checks on the account, The Chairman, Vice-Chairman and Treasurer; and

WHEREAS, The Papago Council has reviewed the budget amendment and approves of the same; and

NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it hereby approves the budget amendment to the FY 84 budget of the Hickiwan District and authorizes expenditures in accordance therewith; and

BE IT FURTHER RESOLVED by the Papago Council that it does hereby authorize the Hickiwan District Council to maintain a separate account with the Valley National Bank in Ajo, Arizona for the expenditures and operation of the gas service project and that the following officers are authorized to draw and sign checks on the account, Chairman, Vice-Chairman and Treasurer; and

BE IT FURTHER RESOLVED that the Papago Council does hereby authorize the Hickiwan District to transfer \$27,500.00 from the funds now on deposit in the District's IIM account into an account with the Valley National Bank in Ajo, Arizona to meet the District's budgeted expenses for the gas service project; and

BE IT FURTHER RESOLVED that the Hickiwan District shall submit on a quarterly basis an account of expenditures and a balance ledger with receipts to the Treasurer of the Papago Tribe to ensure that District funds are being utilized in the proposed manner.

The foregoing Resolution was duly enacted by the Papago Council on the 9th day of August, 1984 at a meeting at which a quorum was present with a vote of 1333.0 for; -0- against; -0- not voting; and 2 absent, pursuant to the authority vested in the Papago Council by Section 2 (f) and Section 3 (a) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is effective as of the date of its approval by the Superintendent of the Papago Agency and is subject to review by the Secretary of the Interior.
