

RESOLUTION OF THE PAPAGO COUNCIL
(Bingo-Bond guaranteeing power payment)

RES. NO. 177-84

2 WHEREAS, on the 14th day of July, 1932, the Papago Council
3 passed Ordinance No. 12-82 for the purpose of regu-
4 lating the operation, conduct and playing of games of
5 bingo on the Papago Reservation, and to produce revenue
6 for support of programs which promote the health,
7 education and welfare of the Papago people; and

8 WHEREAS, a bingo hall has been constructed and bingo games have
9 been conducted therein with all revenue generated there-
10 from being under the direct control of the Papago Tribe;
11 and

12 WHEREAS, it is the responsibility of the Papago Tribe to pay all
13 legitimate expenses of the operation of the Bingo games,
14 including all power bills connected therewith; and

15 WHEREAS, the supplier of power, Tucson Electric Power Company,
16 requires the Papago Tribe to provide a bond from the
17 Tribe's bonding company which would guarantee the
18 payment for power used by the Tribe's Bingo operation.

19 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it
20 (1) does hereby agree to indemnify and exonerate the
21 Aetna Casualty and Surety Company, or any other surety
22 or co-surety, from and against any and all loss and
23 expense up to but not to exceed \$15,000.00 for failure
24 of the Tribe to pay Tucson Electric Power Company for
25 power used by the Tribe in its Bingo operation, plus
26 any additional losses and expenses of whatever kind,
27 including interest, court costs and counsel fees, which
28 the bonding company may occur or sustain as a result of
29 or in connection with the furnishing of said bond; (2)
30 does hereby agree to pay all premiums as they fall due;
31 and does hereby authorize and direct the Chairman, Vice
32 Chairman, Secretary, Treasurer or other appropriate
officers of the Papago Council to execute on behalf of
the Papago Tribe any agreement or agreements of in-
demnity required by the Aetna Casualty & Surety Company,
or any other surety or co-surety, as a pre-requisite to
the execution by them of this bond or undertaking
for the Papago Tribe.

The foregoing Resolution was duly enacted by the Papago Council
on the 9th day of August, 1984, at a meeting at which a
quorum was present with a vote of 1333 for; 0 against; 0
not voting; and 3 absent pursuant to the authority vested in
the Papago Council by Section 2(a), (e) and (f) and Section 3 (a),
(e), (g) and (h) of Article V of the Constitution and By-laws of
the Papago Tribe of Arizona, as amended, ratified by the Papago
Tribe on December 12, 1936, and approved by the Secretary of the
Interior on January 6, 1937, pursuant to Section 16 of the Act of
June 18, 1934 (48 Stat. 984). Said Resolution is subject to re-
view by the Secretary of the Interior and is effective as of the
date of its enactment by the Papago Council.
