

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL


San Xavier District Budget - FY 85

Res No. 178-84

1 WHEREAS; The San Xavier District Council has considered and reviewed its
2 proposed activities for FY 85 and has prepared a proposed budget to
3 cover anticipated costs and expenses; and
4 WHEREAS; The San Xavier District Council did by Resolution No. 7-84-9 adopt
5 a proposed budget for FY 85 in the amount of \$109,764.00, said
6 budget to begin on October 1, 1984 and end on September 30, 1985;
7 and
8 WHEREAS; The San Xavier District maintain an account at the First Interstate
9 Bank of Arizona, 150 N. Stone, Tucson, Arizona and has authorized the
10 following officer of the District Council to have authority to sign
11 checks on the Account, Chairman, Vice-Chairman, Treasurer & Secretary;
12 and
13 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby approve
14 the attached FY 85 budget of the San Xavier District and authorizes
15 expenditures in accordance therewith; and
16 BE IT FURTHER RESOLVED by the Papago Council that it does hereby authorize the
17 San Xavier District Council to maintain a separate District Checking
18 and/or Savings Account with the First Interstate Bank of Arizona, 150
19 N. Stone, Tucson, Arizona which shall provide that any of the following
20 officers of the District Council are authorized to draw funds from
21 such account (s), Chairman, Vice-Chairman, Treasurer & Secretary; and
22 BE IT FURTHER RESOLVED that the Papago Council does hereby authorize the San
23 Xavier District to transfer funds on deposit in the District's IIM
24 Account into an account with First Interstate Bank of Arizona, Tucson,
25 Arizona an amount not to exceed the total budget of \$109,764.00 to
26 meet the District's budgeted expenses; and
27 BE IT FURTHER RESOLVED that the San Xavier District shall submit on a quarterly
28 basis an account of expenditures and a balance ledger statement with
29 receipts to the Treasurer of the Papago Tribe to ensure that District
30 funds are being utilized in accordance with the budget.

31 The foregoing Resolution was duly enacted by the Papago Council on the 20th day
32 of August, 1984, at a meeting at which a quorum was present with a vote of
1159.9 for; -0- against; 53.5 not voting; and 4 absent, pursuant to the
authority vested in the Papago Council by Section 2 (f) and Section 3 (a) of
Article V of the Constitution and By-laws of the Papago Tribe of Arizona as
amended, ratified by the Papago Tribe on December 12, 1936, and approved by
the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of
the Act of June 18, 1934 (48 Stat. 984). Said Resolution is effective as
of the date of its approval by the Superintendent of the Papago Agency and
is subject to review by the Secretary of the Interior.
