10	NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby approve						
11	the attached FY 85 budget of the San Xavier District and authorizes						
	expenditures in accordance therewith; and						
12	BE IT FURTHER RESOLVED by the Papago Council that it does hereby authorize the						
13	San Xavier District Council to maintain a separate District Checking						
14	and/or Savings Account with the First Interstate Bank of Arizona, 150						
15	N. Stone, Tucson, Arizona which shall provide that any of the following						
, 5:	officers of the District Council are authorized to draw funds from						
16	such account (s), Chairman, Vice-Chairman, Treasurer & Secretary; and						
17	BE IT FURTHER RESOLVED that the Papago Council does hereby authorize the San						
18	Xavier District to transfer funds on deposit in the District's IIM						
19	Account into an account with First Interstate Bank of Arizona, Tucson,						
	Arizona an amount not to exceed the total budget of \$109,764.00 to						
20	meet the District's budgeted expenses; and BE IT FURTHER RESOLVED that the San Xavier District shall submit on a quarterly						
21	basis an account of expenditures and a balance ledger statement with						
22	receipts to the Treasurer of the Papago Tribe to ensure that District						
23	funds are being utilized in accordance with the budget.						
	The foregoing Resolution was duly enacted by the Papago Council on the 20th day						
24	of August, 1984, at a meeting at which a quorum was present with a vote of 1159.9 for; -0- against; 53.5 not voting; and 4 absent, pursuant to the						
25	authority vested in the Papago Council by Section 2 (f) and Section 3 (a) of						
26	Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by						
27	the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is effective as						
28	of the date of its approval by the Superintendent of the Papago Agency and is subject to review by the Secretary of the Interior.
