Chukut Kuk District Budget - FY 85


1 WHEREAS, The Chukut Kuk District Council has considered and reviewed its  
2 proposed activities for FY 85 and has prepared a proposed budget  
3 to cover anticipated costs and expenses; and  
4 WHEREAS, The Chukut Kuk District Council did by Resolution adopt a proposed  
5 budget for FY 85 in the amount of \$363,521.00, said budget to be-  
6 gin on October 1, 1984 and end on September 30, 1985; and  
7 WHEREAS, The Papago Council has reviewed the proposed budget and approves  
8 of same; and  
9 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby  
10 approve the attached FY 85 budget for the Chukut Kuk District and  
11 authorizes expenditures in accordance therewith.

12 The foregoing Resolution was duly enacted by the Papago Council on the 20th  
13 day of August, 1984, at a meeting at which a quorum was present with a vote  
14 of 1264.5 for; -0- against; and 53.5 not voting; and 2 absent, pur-  
15 suant to the authority vested in the Papago Council by Section 2 (f) and  
16 Section 3 (a) of Article V of the Constitution and By-laws of the Papago  
17 Tribe of Arizona as amended, ratified by the Papago Tribe on December 12,  
18 1936, and approved by the Secretary of the Interior on January 6, 1937,  
19 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said  
20 Resolution is effective as of the date of its approval by the Superintendent  
21 of the Papago Agency and is subject to review by the Secretary of the  
22 Interior.


