

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

Hickiwan District Budget - FY 85

Res No 180-84

1 WHEREAS, The Hickiwan District has considered and reviewed its proposed
2 activities for FY 85 and has prepared a proposed budget to cover
3 anticipated costs and expenses; and

4 WHEREAS, The Hickiwan District Council did by Resolution No. 4-84 adopt a
5 proposed budget for FY 85 in the amount of \$161,688.00 said budget
6 to begin on October 1, 1984 and end on September 30, 1985; and

7 WHEREAS, The Hickiwan District maintains an account at the Valley National
8 Bank in Ajo, Arizona, and has authorized the following officers of
9 the District Council to have authority to sign checks on the account,
10 The Chairman, Vice-Chairman and Treasurer; and

11 WHEREAS, The Papago Council has reviewed the proposed budget and approves of
12 the same; and

13 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it hereby approves
14 the Hickiwan District Council Budget for FY 85 and authorizes ex-
15 penditures in accordance therewith; and


16 BE IT FURTHER RESOLVED by the Papago Council that it does hereby authorize the
17 Hickiwan District Council to maintain a separate District Checking
18 and/or Savings Account with the Valley National Bank in Ajo, Arizona
19 which shall provide that any of the following officers of the Dis-
20 trict Council are authorized to draw funds from such account (s),
21 the Chairman, Vice-Chairman and treasurer; and

22 BE IT FURTHER RESOLVED that the Papago Council does hereby authorize the
23 Hickiwan District to transfer funds on deposit in the District's IIM
24 Account into an account with the Valley National Bank in Ajo, Arizona
25 an amount not to exceed the total budget of \$161,688.00 to meet the
26 District's budgeted expenses; and

27 BE IT FURTHER RESOLVED that the Hickiwan District shall submit on a quarterly
28 basis an account of expenditures and a balance ledger with receipts
29 to the Treasurer of the Papago Tribe to ensure that District funds
30 are being utilized in the proposed manner.

31 The foregoing Resolution was duly enacted by the Papago Council on the 20th
32 day of August, 1984, at a meeting at which a quorum was present with a vote
of 1318.0 for; -0- against; -0- not voting; and 2 absent, pursuant
to the authority vested in the Papago Council by Section 2 (f) and Section
3 (a) of Article V of the Constitution and By-laws of the Papago Tribe of
Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and
approved by the Secretary of the Interior on January 6, 1937, pursuant to
Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is
effective as of the date of its approval by the Superintendent of the Papago
Agency and is subject to review by the Secretary of the Interior.
