

4 Papago Constitution and By-laws, as amended, and that their  
5 applications are approved, as herein above indicated.


6 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of  
7 the Papago Tribe reduce this final determination in writing regarding  
8 each of the foregoing applications for enrollment in accordance with  
9 Section 3 (c) of Article III of the Papago Tribal Enrollment  
10 Ordinance; give notice of this Council's determination in accordance  
11 with Section 4 of Article III of the Papago Tribal Enrollment  
12 Ordinance; and place the names of each applicant upon the Tribal  
13 membership roll in accordance with Article V of the Papago Tribal  
14 Enrollment Ordinance.

15 The foregoing Resolution was duly enacted by the Papago Council on the 30th.  
16 day of August, 1984, at a meeting at which a quorum was present with a vote  
17 of 1386.5 for; -0- against; 53.5 not voting; and -0- absent, pursuant  
18 to the authority vested in the Papago Council by Article II and Article V,  
19 Section 2 (f) of the Constitution and By-laws of the Papago Tribe of Arizona  
20 as amended, ratified by the Papago Tribe on December 12, 1936, and approved  
21 by the Secretary of the Interior on January 6, 1937, pursuant to Section 16  
22 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject  
23 to review by the Secretary of the Interior and is effective as of the date  
24 of its enactment by the Papago Council.
