

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

Base Roll Additions - August 1984

Res No 185-84

1 WHEREAS, Section 1 (a) of Article II of the Constitution of the Papago Tribe
2 as amended, provides that the Papago Council can make additions and
3 changes to the official census rolls of the Sells and Gila Bend Res-
4 ervations dated January 1, 1937, and of the San Xavier Reservation
5 dated January 1, 1940, subject to the approval of the Secretary of
6 the Interior; and

6 WHEREAS, The Enrollment Committee has determined that the following named
7 persons were members of the Papago Tribe on the date of the re-
8 spective census rolls but that their names had been inadvertently
9 omitted therefrom, and has recommended that their names be added
10 to the rolls; and

10 WHEREAS, The Papago Council has reviewed the recommendations of the Enrollment
11 Committee and approves thereof; and


11 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that, subject to the
12 approval of the Secretary of the Interior, the names of the follow-
13 ing persons be added to the official census rolls of the Sells,
14 Gila Bend or San Xavier Reservation, to wit:

18 BE IT FURTHER RESOLVED that the required approval be secured from the Sec-
19 retary of the Interior before their names be formally added to such
20 rolls.

20 The foregoing Resolution was duly enacted by the Papago Council on the 30th.
21 day of August, 1984, at a meeting at which a quorum was present with a vote
22 of 1386.5 for; -0- against; 53.5 not voting; and -0- absent, pursuant
23 to the authority vested in the Papago Council by Section 1 (a) of Article II
24 and Section 2 (f) of Article V of the Constitution and By-laws of the Papago
25 Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936,
26 and approved by the Secretary of the Interior on January 6, 1937, pursuant to
27 Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not
28 subject to review by the Secretary of the Interior and is effective as of the
29 date of its enactment by the Papago Council.
