Adoption Into Tribal Membership - August 1984

18 Committee and the evidence submitted in support of the individual
19 applications.

21 adoptions filed by:



27 The foregoing Resolution was duly enacted by the Papago Council on the 30th
28 day of August, 1984, at a meeting at which a quorum was present with a vote
29 of 1333.0 for; -0- against; 107.0 not voting; and -0- absent, pur-
30 suant to the authority vested in the Papago Council by Section 2 of Article
31 II of the Constitution and By-laws of the Papago Tribe of Arizona as amended,
32 ratified by the Papago Tribe on December 12, 1936, and approved by the Sec-
retary of the Interior on January 6, 1937, pursuant to Section 16 of the Act
of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review
by the Secretary of the Interior and is effective as of the date of its
enactment by the Papago Council.


