


RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
Accept Recommendations of Law & Order Committee


Res No. 192-84

1 WHEREAS, The Law & Order Committee has advised the Papago Council of certain
2 conduct by Chief Judge Antone; and
3 WHEREAS, The Papago Council is satisfied that sufficient information has been
4 provided and finds that there are questions of improper conduct by
5 the Chief Judge Antone; and
6 WHEREAS, The Chief Judge is subject to Papago Council review and discipline
7 pursuant to Article V, Section 3 (b) of the Papago Constitution; and
8 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
9 reprimand the Chief Judge and directs him to remedy the issues of
10 concern.
11 The foregoing Resolution was duly enacted by the Papago Council on the 6th,
12 day of September, 1984, at a meeting at which a quorum was present with a vote
13 of 1072.5 for; 122.5 against; 245.0 not voting; and 1 absent, pursuant
14 to the authority vested in the Papago Council by Section 2 (e), (h) and (f)
15 and Section 3 (b) of Article V of the Constitution and By-laws of the Papago
16 Tribe of Arizona as amended, ratified by the Papago Tribe on December 12,
17 1936, and approved by the Secretary of the Interior on January 6, 1937, pur-
18 suant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Res-
19 olution is effective as of the date of its approval by the Superintendent
20 of the Papago Agency and is subject to review by the Secretary of the
21 Interior.


