WHEREAS, The Law & Order Committee has advised the Papago Council of certain 1 conduct by Chief Judge Antone; and 2 WHEREAS, The Papago Council is satisfied that sufficient information has been provided and finds that there are questions of improper conduct by 3 the Chief Judge Antone; and 4 WHEREAS, The Chief Judge is subject to Papago Council review and discipline 5 pursuant to Article V, Section 3 (b) of the Papago Constitution; and NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby 6 reprimand the Chief Judge and directs him to remedy the issues of 7 concern. 8 The foregoing Resolution was duly enacted by the Papago Council on the 6th. day of September, 1984, at a meeting at which a quorum was present with a vote of 1072.5 for; 122.5 against; 245.0 not voting; and 1 absent, pursuant to the authority yested in the Papago Council by Section 2 (e), (h) and (f) and Section 3 (b) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
