


RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

Sells District Budget - FY 85


Res No. 194-84

1 WHEREAS, The Sells District Council has considered and reviewed its proposed
2 activities for FY 85 and has prepared a proposed budget to cover
3 anticipated costs and expenses; and
4 WHEREAS, The Sells District Council did by Resolution No 1084 adopt a proposed
5 budget for FY 85 in the amount of \$331,352.00 said budget to begin on
6 October 1, 1984 and end on September 30, 1985; and
7 WHEREAS, The Papago Council has reviewed the proposed budget and approves of
8 the same; and
9 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it hereby approves
10 the Sells District Council Budget to be expended in accordance with
11 the attached budgets.
12 The foregoing Resolution was duly enacted by the Papago Council on the 6th. day
13 of September, 1984, at a meeting at which a quorum was present with a vote of
14 1440.0 for; -0- against; -0- not voting; and 1 absent, pursuant to
15 the authority vested in the Papago Council by Section 2 (f) and Section 3 (a)
16 and (h) of Article V of the Constitution and By-laws of the Papago Tribe of
17 Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and
18 approved by the Secretary of the Interior on January 6, 1937, pursuant to
19 Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is
20 effective as of the date of its approval by the Superintendent of the Papago
21 Agency and is subject to review by the Secretary of the Interior.


