

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
Gu Achi District Budget - FY 85

Res No. 195-84

1 WHEREAS, The Gu Achi District Council has considered and reviewed its pro-
2 posed activities for FY 85 and prepared a budget to cover anticipated
costs and expenses; and

3 WHEREAS, The Gu Achi District Council did by Resolution on August 15, 1984
4 approve the proposed budget for FY 85 in the amount of \$145,269.17
5 said budget period to begin on October 1, 1984 and end on Sept-
ember 30, 1985; and

6 WHEREAS, The Gu Achi District maintains an account at the Valley National Bank,
7 Casa Grande, AZ. and has authorized the following officers of the
8 Council to have authority to sign checks on the Account, The Chair-
man and Treasurer; and

9 WHEREAS, The Gu Achi District Council has sufficient funds in its IIM Account
10 to cover the proposed budget; and

11 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
12 approve the attached FY 85 budget of the Gu Achi District and
authorizes expenditures in accordance therewith; and


13 BE IT FURTHER RESOLVED by the Papago Council that it does hereby authorize
14 the Gu Achi District Council to maintain a separate District Checking
15 and/or Savings Accounts with the Valley National Bank, Casa Grande,
16 Arizona, which shall provide that any of the following officers of
the District Council, i.e., the Chairman and Treasurer, are auth-
17 orized to draw funds from such account (s); and

18 BE IT FURTHER RESOLVED that the Papago Council does hereby authorize the Gu
19 Achi District to transfer funds on deposit in the District's IIM
20 account into an account with The Valley National Bank, Casa Grande,
Arizona an amount not to exceed the total budget of \$145,269.17 to
21 meet the District's budgeted expenses; and

22 BE IT FURTHER RESOLVED that the Gu Achi District shall submit on a quarterly
23 basis an account of expenditures and a balance ledger statement with
receipts to the Treasurer of the Papago Tribe to ensure that District
24 funds are being utilized in accordance with the budget.

25 The foregoing Resolution was duly enacted by the Papago Council on the 6th. day
of September, 1984, at a meeting at which a quorum was present with a vote of
1440.0 for; -0- against; -0- not voting; and 1 absent, pursuant to
26 the authority vested in the Papago Council by Section 2 (f) and Section 3 (a)
of Article V of the Constitution and By-laws of the Papago Tribe of Arizona
27 as amended, ratified by the Papago Tribe on December 12, 1936, and approved
by the Secretary of the Interior on January 6, 1937, pursuant to Section 16
28 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is effective
as of the dat of its approval by the Superintendent of the Papago Agency and
29 is subject to review by the Secretary of the Interior.
